Conditions of membership

- Members are expected to adhere to applicable laws, regulations and customs.
- Members have a responsibility to be inclusive and to show respect and courtesy to fellow participants.
- Members are expected to minimise their impact on the environment.
- Members shall support the purposes of the Club and adhere to its Rules of Association.
- People signing up for any Club activity should understand that the Club, its leaders and organisers are not responsible for any injury, loss or damage suffered by anyone participating in any Club activity.
- It is the participant's responsibility to disclose to the leader medical conditions (plus the location of any medicine and instructions that might be needed), injuries, disabilities, or any other concerns which may affect his or her ability to complete the activity or may hinder the progress of the group.
- Participants should be aware that the activity may expose them to risks that could lead to injury, illness or death or to loss of or damage to their property. These risks include, but are not limited to, slippery and/or uneven walking surfaces, rocks being dislodged, swimming, diving, submerged logs and rocks, shallow and/or cloudy water, hypothermia, strong currents, snakes, sun/heat related problems, etc.
- All participants must ensure that the activity is within their capabilities, and that they are carrying enough food, water, clothing and equipment appropriate for the activity.
- The leader has the right to refuse a person access to an activity if it is uncertain that these conditions of booking can be adequately met.
- All participants should follow directions given by the leader and should not leave the group without the leader's consent.
- Breaches of these conditions are handled according to the Club's Code of Conduct.
